ABOUT AOJ AND THE ANNUAL CONVENTION

Founded in 1947 as the National Conference of Editorial Writers, the Association of Opinion Journalists is a nonprofit professional organization that exists to improve the quality of editorial pages, and broadcast editorials, and to promote high standards among opinion writers and editors.

This year's Annual Convention will be held October 13-15 at the Hyatt Regency Newport, 1 Goat Island, Newport, R.I. 02840. The convention will officially begin with a dinner on Sunday, October 13, and close with a Tuesday evening banquet.

Participants in the convention will include opinion writers and editors for general-circulation newspapers, radio or television stations, and online outlets. Also in attendance will be several syndicated columnists, journalism teachers and students, and many others who determine the editorial policies of media outlets across the nation.


